### Direction to Show Site

Address: 13835 Aberdeen St NE, Ham Lake, MN 55304

**From the North:** I-35 south to CR-2 exit, EXIT 131, toward US-8/FOREST LAKE. Turn RIGHT onto W BROADWAY AVE/CR-2 W and go 6.9 miles. Turn LEFT onto LEXINGTON AVE NE/CR-17/CR-18 and continue for 4.8 miles. Turn RIGHT onto BUNKER LAKE BLVD NE/CR-116 W, for 3.5 miles. Turn RIGHT onto ABERDEEN ST NE for 1 block. Facility is on the right.

**From the South:** I-35W north. Merge onto US-10 W via EXIT 30 toward ANOKA for 2.8 miles. EXIT on HWY 65 (Central Ave) and turn RIGHT traveling for 6.1 miles. Turn RIGHT at BUNKER LAKE BLVD. Turn LEFT on ABERDEEN ST. NE for 1 block. Facility is on the right.

**From the East:** Take I-94 to I-35W NORTH. Merge onto US-10 W via EXIT 30 toward ANOKA for 2.8 miles. EXIT on HWY 65 (Central Ave) and turn RIGHT traveling for 6.1 miles. Turn RIGHT at BUNKER LAKE BLVD. Turn LEFT on ABERDEEN ST. NE for 1 block. Facility is on the right.

**From St Cloud:** Take Hwy 10 EAST 49 miles. Take the CR-14/MAIN ST exit, turn LEFT. Turn LEFT onto COON CREEK BLVD NW/CR-18 N for 1.6 miles. Turn RIGHT on BUNKER LAKE BLVD and travel 4.7 miles. Turn LEFT on ABERDEEN ST NE for 1 block. Facility is on your right.

## **There is no unreserved/free electrical in the building**

The building can be accessed on Friday for set-up from 2:00 pm until 6:00 pm. The building will be available from 7:00 am until two hours after Best of Breed on Saturday and one hour after Best of Breed on Sunday.

1. If you require electrical service, you must reserve it in advance at a cost of \$35 per plug for the weekend. (No splitters allowed) Grooming space is provided free of charge and will be assigned based on your total number of crates and tables.
2. Space will be assigned in the order received. Number of spaces is limited.
3. No phone reservations will be accepted.
4. No reservations will be accepted without payment in full. US funds **only** will be accepted. Returned checks **do not** constitute a valid reservation fee.
5. If you are requesting to be set up next to another exhibitor, spaces may be combined; please be sure all parties are aware of the request
6. For confirmation of reservations, please include your E-mail address.
7. The Twin Cities Voyageur English Springer Spaniel Association, Inc. reserves the right to consolidate spaces if space is not fully utilized.
8. **No exercise pens** will be allowed indoors in the reserved grooming spaces.
9. **Set-up allowed in assigned spaces only. Any equipment placed in unauthorized areas will be confiscated at the owner's expense.**
10. All equipment & dogs must be removed one hour after Best in Show on Sunday.
11. There is separate indoor crating space for obedience/rally. Spaces do not need to be reserved.
