# **Directions To The Trial Site**

From the North: I-35 south to CR-2 exit, EXIT 131, toward US-8/FOREST LAKE. Turn RIGHT onto W BROADWAY AVE/CR-2 W and go 6.9 miles. Turn LEFT onto LEXING-TON AVE NE/CR-17/CR-18 and continue for 4.8 miles. Turn RIGHT onto BUNKER LAKE BLVD NE/CR-116 W, for 3.5 miles. Turn RIGHT onto ABERDEEN ST NE for 1 block. Facility is on the right.

<u>From the South:</u> I-35W north. Merge onto US-10 W via EXIT 30 toward ANOKA for 2.8 miles. EXIT on HWY 65 (Central Ave) and turn RIGHT traveling for 6.1 miles. Turn RIGHT at BUNKER LAKE BLVD. Turn LEFT on ABERDEEN ST. NE for 1 block. Facility is on the right.

<u>From the East:</u> Take I-94 to I-35W NORTH. Merge onto US-10 W via EXIT 30 toward ANOKA for 2.8 miles. EXIT on HWY 65 (Central Ave) and turn RIGHT traveling for 6.1 miles. Turn RIGHT at BUNKER LAKE BLVD. Turn LEFT on ABERDEEN ST. NE for 1 block. Facility is on the right.

<u>From St Cloud:</u> Take Hwy 10 EAST 49 miles. Take the CR-14/MAIN ST exit, turn LEFT. Turn LEFT onto COON CREEK BLVD NW/CR-18 N for 1. 6 miles. Turn RIGHT on BUNKER LAKE BLVD and travel 4.7 miles. Turn LEFT on ABERDEEN ST NE for 1 block. Facility is on your right.

# **Information For Exhibitors**

ACT1/ACT1J: ACT1/ACT1J are entry level tests that are open to all dogs that have not earned a title in any AKC Agility class and that meet the age and physical requirements for a regular AKC agility trial (Chapter 1, Section 3). Dogs must have two passing ACT1 scores in order to earn the ACT1 title. For ACT1J dogs must have two passing ACT1J scores to earn the ACT1J title. To receive the title certificate and have the title added to a dog's record, the dog must be registered/listed with the AKC.

ACT2/ACT2J: ACT2 (Standard)/ACT2J (Jumpers). ACT2/ACT2J are the second level Agility Course Tests that are open to all dogs that have dogs that have not earned a title in any AKC Agility class and that meet the age and physical requirements for a regular AKC agility trial (Chapter 1, Section 3). Dogs must have two passing ACT2 scores in order to earn the ACT2 title. For ACT2J dogs must have two passing ACT2J scores to earn the ACT2J title. To receive the title certificate and have the title added to a dog's record, the dog must be registered/listed with the AKC.

<u>Obstacles</u>: Obstacles will conform to current requirements of the Regulations for Agility Trials.

<u>Warm-Ups</u>: A warm-up area consisting of a regulation agility jump will be provided for all exhibitors.

Ringside: Dogs are not required to be at the trial until the scheduled time of judging. All dogs not needed for further judging are excused. The owner/handler of each dog is solely responsible for having it ready at ringside when the class is to be judged. Please help your fellow competitors, the trial workers, and the judge by checking in with the gate steward well ahead of your run, and being prompt at the line when your turn comes to run.

<u>Dogs Eligible to Enter</u>: As it states in the Regulations for Agility Trials, Chapter 1, Section 3, All dogs fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number, or approved Foundation Stock Service (FSS) breeds are eligible to participate except bitches in heat, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect the dog's physical or mental performance. Dogs or register able breeds with accepted foreign registration numbers are eligible to participate.

<u>Height Divisions</u>: Dogs may be entered at any of the following jump height divisions: 4, 8, 12, 16, 20 or 24 inches. There is no Regular or Preferred distinction in the ACT program. A jump height card is not required to enter an ACT event, but handlers are encouraged to have their dogs measured if a VMO is available.

#### **Prize and Awards:**

## Information For Exhibitors Cont.

Refunds: Entry fees for bitches that come into season and injured dogs after the closing date will be refunded with a veterinary note presented to the trial secretary. Request for refunds must be made prior to the start of judging. No entry fees will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, or any other cause beyond the control of the organizing committee. Entry fees shall not be refunded in the event that a dog is absent, disqualified, excused by vet or judge, or barred from competition by action of the trial committee.

<u>Safety/Behavior</u>: The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rule and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely. Exhibitors should follow their veterinarian's recommendation to assure their dogs are fee of internal and external parasites, any communicable diseases, and have appropriate vaccinations. All dogs present must be on leash or confined to their crates except when being judged or when using the warm-up jump.

<u>Liability</u>: It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitors whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such cases, no refund of any fees paid will be made. The <u>Xtreme K9 Dog Sports</u>, On The Run! Canine Center, and its agents, employees, ect. will not assume responsibility for any loss, damage, or injury sustained by exhibitors or handlers, or to any of their dogs or property, and further assume no responsibility for injury to children.

<u>Crating</u>: No Ex-pens allowed. Crates may be left overnight; however <u>Xtreme K9 Dog Sports</u> and On the Run! Canine Center will not be responsible for any lost or damaged items left at the show site.

<u>Entry Fees</u>: Exhibitors must submit entries with checks drawn on US accounts or with international money orders payable in US funds.

I certify that I am the actual owner of the dog, or that I am the duly authorized agent of the actual owner whose name I have entered. In consideration of the acceptance of this entry, I (we) agree to abide by the rules and regulations of The American Kennel Club in effect at the time of this event, and any additional rules and regulations published for this event and any decision made in accord with them and further agree to be bound by this Agreement. I (we) agree that the club or ACT Evaluator, holding this event has the right to refuse this entry for cause which the club or ACT Evaluator shall deem sufficient. I (we) certify and represent that the dog entered is not a hazard to persons or other dogs. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents, event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge or ACT Evaluator, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog. #### INSTRUCTIONS

Dogs may be entered in any jump height. There is no Regular or Preferred distinction at AKC's ACT events.

In order to acquire the ACT1 or ACT2 title certificate and have the title added to a dog's record, the dog must be registered/listed with the American Kennel Club. **AKC Canine Partners**<sup>SM</sup> applications may be accepted at the event and submitted to AKC with the event's results.

Dogs that are not AKC registered/listed may be registered at a later date and receive their ACT title at that time.

Dogs listed in the **AKC Canine Partners<sup>sM</sup>** program should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.

**Junior Handlers** should enter their Junior Handler Number on the front of this form. Should you not have your Junior Handler number, it may be obtained from the American Kennel Club (919) 233-9767. If the Junior Handler is not the owner of the dog identified on the face of this form, what is the relationship of the Junior Handler to the Owner?
