Conditions of Entry

All dogs must have an AKC registration number and be at least one year of age on the day of the trial. Dogs may only run once per test. All entries must be accompanied with a Check payable to the Xtreme K9 Dog Sports to be valid. Entries received by phone, text or email will not be accepted. Incomplete entries or forms without a signature will not be accepted.

Fast CAT events are open to all dogs at least 12 months of age that are individually registered with the AKC, recorded in the Foundation Stock Service (FSS) program, individually registered with the foreign or domestic registry organization whose pedigrees are acceptable for AKC registration, dogs granted a Purebred Alternative Listing (PAL) number, dogs with AKC Limited or Conditional Registration, or dogs enrolled in the AKC Canine Partners Program. Dogs with breed disqualifications and monorchid/cryptorchid Dogs are eligible to participate.

What is Fast CAT

Fast CAT (Fast Coursing Ability Test) is a timed straight 100-yard dash for dogs. Dogs are held at the start line and the coursing lure is activated prompting the dog to follow chasing it to the finish line and into a catch pen. The course is completely fenced, and dogs are run individually. Dogs are timed when they complete the 100-yard dash. The time is converted to miles per hour (MPH).

$$204.545 / \text{run time} = \text{MPH}$$

Points = MPH multiplied by the dog's handicap (rounded to the nearest 0.01MPH)

A dog's handicap is determined by the height of the dog at the withers, a handicap is applied, and points are earned.

18" or greater = Handicap multiplier - 1.0

12" to 18" = Handicap multiplier - 1.5

12" and below = Handicap multiplier - 2.0

Titles are earned at specific point levels and the highest suffix may appear after the dog's name:

BCAT = 150 points

DCAT = 500 points FCAT = 1000 points

FCAT2 = 1500 points

FCAT#... For each additional 500 points

Coursing is an athletic activity that can tax a dog's physical strength. Dogs that are overweight and/or out of condition may be at greater risk for injury and exhaustion. The Inspection committee has the authority to disallow a dog's entry into a test. At roll call, dogs may be measured by a wicket to verify handicaps. Bitches in season with either a visual inspection or a letter from a vet will receive entry refund. Lameness and unfit dogs will be excused with a refund per AKC Regulations for FAST CAT.

Top 20 by Breed by Year

The AKC fast cat website will feature the top 20 fastest dogs by breed by year national standings. The standings will be updated as event results are processed at

Hours

Roll Call and visual inspection begin no later than 2:00PM for the 2:30PM run block (Friday) & 7:30 AM for the 8AM run block (Saturday and Sunday). It is the responsibility of each entrant to make an effort to be ready when their dog is called to the line. The runs begin at 8:00 AM to 3:00PM or until all runs are completed. For the safety of our volunteers and participants, lightning is the only reason to cause the postponement and or cancellation of an event. Any dog that is not present by the time the test ends will be considered absent.

- All dogs run at owner sole risk
- All dogs must be 12 months of age or older on the day of the test.
- All dogs must be leashed on trial property. **No electronic or prong collars permitted on trial grounds.**
- All AKC rules regarding sportsmanship and conduct apply.
- This is a rain or shine outdoor event. Please plan accordingly. Please bring your own shade, chairs, and water.
- A Block Scheduling System will be used at these tests. Once the pre-entry time frame has closed, a link to sign up for a time slot will be sent out for exhibitors to sign up for a time slot.
- The grounds are not completely fenced.
- The FastCAT course is completely fenced. The finish will have a minimum of 50 yards run-out, more if the space allows it.
- Lure Equipment: Continuous Loop System. The lure will consist of white plastic bags. The Running Surface is Grass.
- Bathrooms/Portable will be available.
- All dogs must be on a lead or crated unless running.
- Owners are expected to clean up after their dogs.
- Each dog requires an individual entry form.
- You're responsible for controlling your dog and/or children.
- The field committee is responsible for field safety and therefore in complete charge of all dogs and handlers on the field. In service to this responsibility, they have the authority to stop the lure in any potentially dangerous situation and signal the handler to retrieve the dog on the course.
- Dogs and/or people exhibiting conduct detrimental to CVTC/AKC will be asked to leave the trial site by the field committee and may be disciplined by the AKC. Entry fees will not be refunded.
- Fees shall not be refunded in the event a dog is absent. No entry fees will be refunded if the event cannot be started or completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, acts of God, public emergency, act of a public enemy, strikes or any other causes beyond the control of CVTC.
- Refunds will be made if, in the opinion of the Inspection Committee, for any entry found to be lame, unfit to compete, a female in season or for any other reason found to be barred from competition according to regulations governing this event. Refunds for bitches in season will be refunded if requests are submitted to the Field Secretary prior to the end of roll call for the time block there are entered in, which is considered at the start of the time block.
- The event hosting club, its agents, members, representatives, volunteers, etc., assume no liability or responsibility for any loss, damages or injuries sustained by exhibitors, handlers, or to any of their dogs or property and further assumes no responsibility for injury to children or spectators before, during, or after this event.
- These tests will run concurrently.
- For dogs running in both events on the same day, they must be inspected prior to each run.
- Please have a person to release your dog and to catch your dog **BEFORE** running. There might be volunteer releasers, **but it is not guaranteed.**
